LIMITS ON TTD	
Waiting period	3 days
Total TTD allowed	104 weeks
Total consequential injury	52 weeks
Start within notice of injury	15 days
Soft Tissue	8 weeks
Injection	8 weeks
Surgical recommendation	16 weeks
Cl. on unemployment	No full TTD
Total TPD allowed	52 weeks

FORMS TO FILE	DEADLINE
CC-Form-2 (First Report of Injury)	Within 10 days of notice of injury (more than 3 days missed from work)
CC-Form-2A (Intent to Dispute)	Within 15 days of notice of injury
CC-Form 2A Extension	Filing provides an additional 15 days to controvert
EOA/CC-Form-71	Within 10 days of notice of Form 3

EMPLOYER DEFENSES/DENIALS FOR FORM-2A'S
Intentional or expected injury
No damage/harm to physical structure of body
Work incident not sole cause
Horseplay or assault in the workplace
Recreational or social injury
Strain injury only
Degenerative condition only or result of aging
Pre-existing condition without S & I aggravation
No medical objective findings of injury
Independent, intervening event cuts off cause
Intoxication/illegal substance/misuse of meds
Injury occurs to or from employment
Injury occurred during personal errand
Injury on work break, outside and unauthorized
Cum. trauma – Deny 180 days cont. employment
Hernia – Did not report within 5 days
Mental – No physical injury (not crime of violence)
Heart Attack – No unusual job duties or event

SOL	TIMEFRAME
Denied	1 year from accident
Denied, but claim filed	1 year from filing if no TTD or medical has been provided
Admitted, but no request for hearing	May be dismissed after 6 months
Admitted and benefits paid	2 years from accident or 1 year from payment of last benefits

TERMINATION OF TTD	
No Claim Filed	Automatic
Claim Filed, Term. Without Order	Cl. returns to full time employment
	Claimant is incarcerated
	Claimant files for PPD
	After sending written notice to Claimant's attorney
	Claimant reaches soft tissue limits
